Legendary sports commentator John Motson spent his last night watching football at a Buckinghamshire pub, it has been confirmed.

The 77-year-old, who was a regular on Match of the Day where he covered 10 World Cups, 10 European Championships, and 29 FA Cup finals for BBC Sport, passed away in the early hours of Thursday, February 23.

It has been revealed that he moved to Buckinghamshire in the later years of his life, and spent his final night watching Manchester City's 1-1 draw with RB Leipzig in the Champions League, at The George Pub in Little Brickhill within the county.

Simon and Louise Babikian, who run the pub, revealed to the BBC that the much-loved commentator would visit the establishment 'three to four times a week'.

Mrs Babikian told the BBC: "Wednesday evening [February 22], the night before he passed, he came into the pub to watch his football match and sat with his mates having a beer and talking us through the game, as he would most evenings."

Mr Babikian added: "I think this was his special place.

A diverse future for MK



On 1 March, more than 120 colleagues and partners joined us at MK Gallery for a thought-provoking event on Planning for Growth and Diversity in Milton Keynes.

MKCC Planning Policy Manager Andrew Turner and MK Futures Programme Manager Fiona Robinson had put together a range of speakers and sessions on how communities across the city are changing and how we embed diverse voices in the preparation of our New City Plan.

There were also discussions on how we create healthy places, as well as high quality and sustainable housing and economic growth.



Secondary school places announced

During the week of 1 March 2023, thousands of MK pupils found out which secondary school they'll be moving to in September. MKCC received almost 4,000 applications for secondary school places and 94% of children secured one of their top choices.

In recent years MKCC has helped to create more than 13,600 new school places by building six new schools and helping 24 more expand; we do a lot of work making sure the number of places are in line with demand, as well as a significant logistics job of matching children to their preferred schools.

As you have all been involved in trying to return trains to the Marston Vale Line, I have decided to write you with my view on behalf of the Rail Users Association, following yesterday's Stake Holder Meeting hosted by London Northwestern Railway (LNR). This may or may not frame a more general response from all with regard to the situation.

We do not accept the decision to withdraw the Class 230s in the short term. Whilst it may be difficult to obtain suitable spares and maintain the trains, we do not believe this

is impossible - they have performed latterly quite well on the line and we believe the decision to withdraw may be largely based on the cost rather than feasibility of their continued operation. Should a full service with these trains prove impossible to maintain as alluded to by LNR's Engineering Director yesterday, then a reduction to a partial service over the coming months would be more acceptable to our users than complete rail replacement.

We do accept that it may not be justifiable to retain these units in thier current form long term. We are however disappointed by the return of Class 150 units. These are old, first introduced to the line over twenty yeas ago and we are already hearing reactions from within our committee like this is closure by stealth. However, this may be the most pragmatic medium-term solution, although we are not entirely convinced of this. Of greater concern is the lack of definitive timescale presented in by LNR yesterday. We will not rest at all easy until units actually arrive at Bletchley and driver training commences and are concerned that further slippage to timescale may occur as trains are not cascaded to schedule and driver training takes longer than anticipated.

We are concerned that we will now see decline in usage of the Marston Vale Line which will lead to its existence being once again threatened. East West Rail may be many years away, and to our users it is not viewed as a certainty, and even if it does come will mean they are faced with new challenges, including possible closure of stations with short platforms, which we would largely oppose. Against this background our preferred solution would be short term return of the Class 230s to service, medium term replacement of the 230s with alternative stock, during which the case for converting the 230s from unreliable diesel traction to battery power be examined. This may seem like a pipe dream but is still under active consideration elsewhere on the network and would see modern sustainable trains designed for the Marston Vale Line returned to service. We believe this would permit confidence in the line to be maintained and enhanced.

In recent years, we've successfully prosecuted more than 30 people for fly tipping, resulting in fines of more than £25,000. Offenders can face prison sentences of up to 5 years or fines up to £50,000 for crimes like these.

Our Fly Tipping Action Plan https://www.milton-keynes.gov.uk/sites/default/files/2022-03/Fly-Tipping%20Action%20Plan%20PAA.pdf clearly sets out what we will to do in the months and years ahead to support and work with residents, businesses, partners, and communities to tackle fly-tipping. We know where the hot spots in MK are, and we use CCTV to tackle environmental crime. Council vehicles are fitted with dash cams which means we can catch people littering out of their cars and other anti-social behaviour.

Waste collection company Suez awarded contract as Milton Keynes prepares to welcome wheelie bins

Milton Keynes City Council has awarded a new contract to SUEZ Recycling and Recovery UK Ltd to collect MK's waste, keep streets clean, and maintain council owned green spaces and



play areas.

The contract starts in September 2023 alongside the vast majority of Milton Keynes 119,000 households moving to wheelie bins, following a public consultation where three quarters of those local people who responded chose wheelie bins over plastic sacks.

Introducing wheelie bins should lead to less street litter, a reduced food supply for rodents and, importantly, higher recycling rates, which will be better for the environment and saves on the production of millions of plastic sacks, the City Council says.

Milton Keynes produces around 121,000 tonnes of household waste and recycling each year, of which 52% is currently recycled.

More than 300,000 bins and accompanying waste vehicles will be manufactured and delivered to MK for summer 2023 in a massive logistical operation.

Many of the new waste and landscaping vehicles will be fully electric to reduce local carbon emissions, and the CCTV equipped fleet will include smaller and narrower vehicles, enabling SUEZ collection crews to 'pick up waste more effectively'.

Following an extensive formal tender process by the City Council, SUEZ has been appointed on a five-year contract, with the opportunity to extend the contract further.

The City Council is taking sample wheelie bins to a range of community spaces and libraries in the weeks ahead to meet residents who would like to learn more about the upcoming changes and examine the wheelie bins in person.




Figure 7.31: Woburn Sands Connectivity Option 1

As displayed in the above figure, the search area for a new bridge and road at Woburn Sands extends northward from the railway line towards Newport Road.

Marston Vale Line not expected to be reinstated until autumn

A Milton Keynes councillor has expressed 'disappointment' over the news that the Marston Vale Line might not be reinstated until autumn.

London North Western (LNW) has announced that it does not expect trains to operate on the Marston Vale Line again until the autumn.

It comes after the announcement back in December that line was being temporarily suspended until further notice.

The news followed confirmation that Vivarail had entered administration.

"Without the guarantee of effective maintenance cover for the fleet London Northwestern Railway have been left with no option but to temporarily suspend the service whilst a solution is found.

"A full rail replacement bus service (all stations and limited stop) will be provided in the meantime. All vehicles are accessible," Marston Vale Community Partnership explained.

The Marston Vale Line runs from Bletchley to Bedford.

Local Conservative Leader Cllr David Hopkins has expressed his 'disappointment' at the recent news from London North Western after the train company said it no longer anticipates seeing the return of the Class 230 engines that had been specifically adapted from former underground trains to operate on this service.

Instead, it proposes to reintroduce the class 150 engines, withdrawn from the line in 2019.

The Milton Keynes Conservative leader has also raised concerns over the limitations the replacement bus service offers.

However, Cllr Hopkins has applauded LNW for its 'openness and honesty' in admitting its failures in the operation of this service and accepts its determination to overcome these 'obstacles'.

Cllr Hopkins said: "LNW is offering stakeholders a regular briefing session and has produced a detailed Frequently Asked Questions document to be place on social media, town and parish council web sites and the like and we are grateful for this. However, questions remain as to just

LNW got into this position in the first place and just what this means for the longer-term viability of the long campaigned for East West Rail service connecting Oxford and Cambridge (via the Marston Vale line)."

Stop the Arc campaigns to reduce the over-inflated housing target that remains part of the Government's Ox-Cam Arc ambitions.

They are calling for an end to the Oxford-Cambridge Arc while supporting fair, democratic and local development.

Matthew said: "I'm pleased to announce the first round of this year's Community Fund is now open for applications. This is a great opportunity to support community and voluntary groups in reducing crime.

"We're fortunate to have such an active community across the Thames Valley, playing a significant role in helping to tackle local issues around crime prevention and supporting vulnerable groups.

"I have been fortunate to visit some of the groups we've supported in the past, who have benefited from the funding provided to support their communities and help prevent crime across the Thames Valley.

"I look forward to receiving applications which focus on a range of areas within my Police and Criminal Justice Plan including crime prevention, modern crimes such as cybercrime and fraud, and reducing re-offending."

Organisations from across the Thames Valley can apply for grants for projects that support one or more of the PCC's 'Police and Criminal Justice Plan' priorities:

- Strong Local Policing (preventing crime & protecting communities)
- Fighting Serious Organised Crime (protecting vulnerable people)
- Fighting Fraud & Cybercrime (fighting modern crimes)
- Improving the Criminal Justice System (reducing re-offending)
- Tackling illegal encampments (reducing the impact of encampments)

Chief Constable John Campbell, said: "Using money generated from the sale of items seized from criminals that cannot be returned to their rightful owners is a great way of funding worthy projects and other work across the Thames Valley.

"This funding will play a big part in helping voluntary and community groups across the Thames Valley. It will allow them to continue to run projects that play such a big role in preventing crime and protecting our communities.

"As ever, we are particularly keen to receive bids for this money from organisations that support our priority areas."

The closing date for this round of applications is 4pm on Monday 6th February and applications will be considered jointly by the Police and Crime Commissioner (PCC) and the Chief Constable. Stopping financial scammers

MKCC is partnering with Thames Valley Police on a new initiative called Operation Intercept to tackle offenders who exploit vulnerable people for their money.

Sadly, organised networks prey on vulnerable people, befriending their victims and gaining trust before taking their money. Things to look out for include: drug activity, persistent visitors to an address, unexplained injuries and money going missing, among others.

We've already had some good success rooting out repeat offenders, convicting two people just last month who were targeting elderly victims and took £1,800 a month from one person's bank account – they would have lost their home if we hadn't stepped in. Well done to our Anti-Social Behaviour team for their work on this.

Congratulations go to England Captain Leah Williamson who on 28 February at Special Council Meeting became the first person to receive the Freedom of the City of Milton Keynes for her achievements.

Born in Milton Keynes, Leah played for Bletchley from an early age before signing to Arsenal age 9 and representing England from 14. She led the Lionesses to victory in last year's UEFA Women's Euros, becoming the first woman to lift a major trophy for England.





The Context of the Futures Group Meeting on 22nd February 2023 in Woburn Sands

- Over the last ten years, the Library, Summerlin Centre, Sports Hall, Recreation Ground plus other initiatives have all been made possible by Woburn Sands Town Council (WSTC) applying for funding derived from the considerable growth Woburn Sands has experienced (size has increased by 50% over this period)
- WS now facing two huge challenges East West Rail and South East Milton Keynes. The development of the former is as yet unknown whether it goes ahead and how it will affect WS.
- South East Milton Keynes (SEMK) expansion is a certainty and will present both opportunities and challenges to the community
- Outline approval for development of SEMK was incorporated in local plan (PlanMK 2016) and is a certainty which cannot be challenged. The Supplementary Planning Guidance (the SPD) for SEMK was approved by MKCC in January 2022. It sets out the principles and key infrastructure and was drafted after consultation with WSTC and other parish councils
- Key points of the SPD as far as WS is concerned;

3000 new dwellings

Green Buffer zone with sport's pitches and open space centred round the fishing lake

Primary school and combined school Transport/traffic impact and facilities

- Over the next ten years the size of WS is set to almost double, as approx 70% of SEMK within parish of WS
- MKCC has stated that all SEMK applications should be coordinated and has established a Stakeholder Group (all local parish councils including WSTC) to monitor and try to ensure coordination. The two principal developers, which are L&Q and O&H, and others were asked to coordinate their outline plans (particularly housing) at the last Stakeholder Group meeting in November 2022.
- The next Stakeholder meeting is due shortly when joint proposals will be discussed for the main part of SEMK.
- It is important to understand the principles of the planning approval process.
- Planning decisions are the sole responsibility of MKCC; the TC has no power only has the right to be consulted. It cannot appeal against MKCC decisions other than on legal grounds that MKCC has not followed proper procedure. Developers can appeal on planning grounds.
- Two stages in the process which the TC and public can comment on.
- 1. Outline application this is where we are with the main part of SEMK. This gives broad details of nature and location of housing and infrastructure; it establishes the principle of development.
- 2. Detailed application which is where we are with Swan Hill (called Reserve Matters).
- Developer contributions come under two broad headings:
- 1. As part of the construction of the scheme ie roads, schools etc. This is agreed by MKCC as part of the outline approval. Hopefully this takes account of the comments from the TC and others.
- Secondly a cash contribution (paid under a Section 106 Agreement) signed with MKCC as part of the detailed approval. The funds are paid to MKCC and then paid out to third parties under a "bidding" process. This process has funded most of the WS developments in the last ten years
- The purpose of Section 106 funds is to compensate third parties affected by the development. The funds are allocated under specific headings (eg community projects, arts, transport etc). Funds are generally only available for specific projects not running costs, and can be used to enhance existing facilities which need expansion because of the development.
- MKCC officers negotiate the overall size and categorisation of the Section 106 contribution as part of the granting of detailed approval. Important that officers are made aware of the needs of WS which will be affected by the development.

This is what this meeting is all about.

• WS community needs to make sure that the principles and philosophy underlying SEMK will enhance the existing community as well as providing an attractive destination for new residents.

- We can do this in two ways:
- A. Influencing the MKCC decisions made in the approval process of the initial outline application. This has already happened and is a continuous process.
- B. Ensuring we have identified the impact of the new development on the existing WS facilities, and have a reasonably costed proposal to meet these needs so that adequate funds are included in the Section 106 Agreement.

The purpose of the Futures process is to ensure that the views of all residents are considered when responding to the SEMK applications.

What do you expect from the development of SEMK?

What specific facilities do you think need to be included?

How do you envisage links will be developed between "new" WS and "old" WS?

What enhancements to existing facilities need to be provided?

Essentially: What sort of community do you foresee once SEMK is completed??

We propose to establish a small executive (say 10-12) committee which would meet regularly to consider these issues and report back to occasional plenary meetings to ensure that we are on the right track. Committee members would have to commit to the regular meetings and undertake specific project work from time to time; a certain amount of reading planning submissions etc would also be required.

Track laying from Bicester to Bletchley passes the halfway point





There was a sense of excitement in Winslow last week as the new track construction (NTC) train reached Winslow's new railway station, which marks the halfway point for track construction on Connection Stage 1 of East West Rail.

The overall stretch for this stage of East West Rail is 66km and, with 50% of track still to be laid in the area, there'll be more opportunities to catch a glimpse of the NTC train in action down the line.

Moving forward at pace

The NTC train, which is one of only two of its kind in the country, uses a rapid track laying system and works much faster than conventional methods. In fact, it carries enough railway sleepers to install up to 1.1km of track during each 10-hour shift.

To reduce any potential impact these works may have on local communities, the majority of equipment and supporting materials for track construction are delivered to site by rail. This has helped remove around 4,000 lorry journeys from local roads.



All infrastructure work on Connection Stage 1 is due to be completed by summer 2024.

The new station being developed at Winslow is taking shape and is due to be completed later this year. Platform construction began a year ago, with more than 500 pre-cast concrete units being lifted into position within the new railway cutting before work could begin on the station building itself.



Major boost for

advanced rapid transport in MK

A high-speed, driverless transport network could transform the way people get around in Milton Keynes after the City Council successfully secured government funding to research the innovative project.

Advanced Very Rapid Transport (AVRT) is a new concept in mass transit, using automated vehicles on purpose-designed segregated pathways. The City Council secured £200,000 funding to commission a study to determine how the AVRT project could fit in with the city's current and proposed infrastructure. It also builds on the City Council's ambitions to deliver well-planned and sustainable growth through its New City Plan.

The study will look at how AVRT could provide future transport solutions and deliver fast, frequent and reliable public transport. An area of key routes around 18 miles in and around Milton Keynes will be the focus of the study.

Milton Keynes City Council already has ambitious plans to boost MK's smart city reputation through delivering a modern mass transit system. The study will analyse how the systems could be integrated and build on the City Council's innovation and sustainability ambitions.

NOTICE IS HEREBY GIVEN that Milton Keynes City Council has on 28th February 2023 made the above Order under Section 14(1) of the Road Traffic Regulation Act 1984. in order to enable Anglian Water to carry out new connection works from 8th March 2023 – 14th March 2023 (24 Hours).

The effect of the above Order will be to temporarily close part of:

Brickhill Street, South Caldecotte (Southbound) – From its junction with Caldecotte Lake Drive to its junction with Heybridge Crescent.

Whilst the above length of road is closed the alternative route will be via Bletcham Way, A5 and Brickhill Road (and vice versa).

Signs will be erected in advance of the closure to inform members of the public of the forthcoming closure.

The Council is satisfied that the temporary closure Order is necessary to enable works to be carried out on the highway. The temporary Order for Anglian Water will come into effect on 6th March 2023 and remain in effect for a period of 3 month and will take effect at times during the above period only when works are required and only when indicated by the appropriate traffic signs, which will be erected in advance of any closure.

There will be no exemptions from the provisions of the proposed Order except for emergency service vehicles on operational duties.

The closures will be clearly signed in accordance with Chapter 8 of the TSRGD 2016 (The Traffic Signs Regulations and General Directions 2016). All affected properties will be notified of the forthcoming closures at least one week prior to the works taking place.

Any person committing a breach of the order will be liable upon prosecution to such fine as prescribed by the Road Traffic Regulation Act 1984.



In advance of works taking place, there should be notices to advise local residents and other road users or any closures and the dates and times. For some types of work, like resurfacing, lining or gully cleaning please do not park your vehicle in the work area.



Having investigated this matter, I can confirm a breach of	
planning control has occurred. Central Government Guidance	
contained within paragraph 58 of the National Planning Policy	
Framework ((NPPF) 2019) states that:	
"Effective enforcement is important to maintain public	
confidence in the planning system. Enforcement	
action is discretionary, and local planning authorities should	
act proportionately in responding to suspected	

breaches of planning control. They should consider publishing a local enforcement plan to manage enforcement proactively, in a way that is appropriate to their area. This should set out how they will monitor the implementation of planning permissions, investigate alleged cases of unauthorised development and take action where appropriate". As the details have now been approved and discharged subject to planning application 22/01860/DISCON as a part of the planning permission 19/00809/FUL for a new dwelling, enforcement action would not be considered expedient in this instance. I recommend that an application to vary condition (2) attached to 19/00809/FUL, to extend the timeframe from three years, to four years, is invited, to regularise the breach of planning control. Accordingly, this case has been closed.

In line with the NPPF and Council's Enforcement Plan (2020), the degree of harm that arises due to the above unauthorised development is considered to be of a limited and minor nature and as such, formal enforcement action is not considered expedient.



MK City Council is extending a contract to continue supporting

former rough sleepers and ensure they don't end up back on the streets.

Its 'Housing First' programme aims to get rough sleepers into accommodation and provide support to help them work through the often complex reasons they became homeless in the first place, sometimes related to relationship breakdowns, family eviction or loss of private rented accommodation. The programme has helped more than 150 people in the last three years.

MK City Council is now making a decision to approve a six month extension of the contract on 14 November. During that time, further long-term initiatives for rough sleepers will be considered.

The City Council's provides vital services for people sleeping rough or those at risk of homelessness. Earlier this year, it opened a new shelter in Central Milton Keynes which has led to secure homes for 30 rough sleepers, with nearly 90 people using the shelter. Former rough sleepers stay for a short period before accessing further assistance.

This is the latest of multiple initiatives in recent years to support rough sleepers and help them secure a life off the streets for good. As a result, the number of people sleeping rough in the city has dropped significantly. A recent review by the team showed that 24 people were sleeping rough in Milton Keynes, which is fewer than the number of beds available through the City Council's provision, meaning everyone needing a bed could be found one. Everyone found sleeping rough is offered accommodation and support. On this occasion only one person took up the offer but the dedicated outreach team continue to make daily rounds to offer support.
