## **Parishes Forum**

I attended the parishes forum on Thursday 15 June. This is a brief resume.

Nick Hannon provided a presentation relating to the new

- Waste Collection contract
- Street Cleansing contract
- Landscape Maintenance contract and
- Play Area and Maintenance contract.

The waste related contracts are awarded to Suez Recycling and Recovery UK Ltd and Glendale Managed Services Limited (landscape maintenance). Both commence in September.

A copy of the presentation is attached to this report.

Points of interest.

• Parishes will be able to make top up payments for additional work in their area (contact Euan Darling <u>Euan.Darling@Milton-keynes.gov.uk</u> to make arrangements or discuss options).

## Questions raised.

- Delivering bins during the holiday period will this lead to bins being left unattended and thus highlight the fact that people at a particular address are away and thus the property becomes prone to being broken in to?
- Who is cleaning the redways? Who is cleaning the street signs? Who will be clearing grass from gutters? Who is cutting back vegetation, especially overhanging vegetation from Parks Trust land? – the answer to each question was that they are all included in the SUEZ contract.
- Can Parishes have sight of the contract with the contractors?
- Is there a list, street by street, of which streets have bins and which will have sacks instead? (No is the answer it's a property by property decision)
- Will Serco staff TUPE across to Suez? Yes, but there will be a change of process and culture and there will be regular meetings with unions.
- As the bins are being unloaded for delivery carriageway and highways being taken out of use without signs warning of the road blockage.
- Is there Smart Technology on the wheelie bins? No

- Can Parish / Estate wide reviews be undertaken to deal with ongoing issues? -There is a landscape design review underway which will be city wide. This is also looking at replacing inappropriate planting etc and Nick is happy to liaise with Parishes to bring these reviews forward.
- Will Serco landscape staff move across via TUPE and will there be a reduction in pesticide use? Yes, to TUPE but no to reduction in pesticide use. Herbicides do not work so well and lead to damage to pavements, pathways etc leading to much higher maintenance bills in the medium to long term.

## **Accessing Section 106 Funding**

James Williamson outlined the process.

- Parishes were reminded to always set out 106 expectations in any response to a planning consultation.
- A project must always be legally compliant to quality for payments being included.

- New 106 release forms and process notes are available.
- There is a new accessible spending tracker process.

- A planning permission is not officially granted until a S106 agreement is signed.
- Woburn Sands TC asked about 106 contributions in kind for example the new Sports Hall in Woburn Sands. The hall has many snagging issues that Taylor Wimpey appears unwilling to address. Can MKCC help bring Taylor Wimpey to the table and draw up a list of redial / corrective solutions to these issues.
